 All students attending Senior Camp <u>must</u> complete an online WVU ACCESS form. No exceptions.

 If any of these parts of the enrollment process are not completed or filled out, the student <u>will not be allowed</u> to come to Senior Camp. This is WVU's ruling, not HSTA's.
- All students coming to Senior Camp must bring a student ID with photo and WEIS number.

<u>NOTE:</u> The HSTA Health History Form replaces the Medical Release form and the Medications form. DO NOT use the old Medical Release and Medications forms. The Dress Code and the Needs list that were sent to you are for the use of the student and their family and are not returned to the Main Office.
